- David Bremner reports on the Oscar Muriu Lectures, held 4-6 April 2008, focusing on Chinese Mission in Africa. Oscar Muriu, a pastor in Nairobi, advocates a break from the dominant Western based finance model of missions. "Africans tend to think of partnerships—not in a business model, but rather one of marriage or family. In this system, partnerships are for life. They are built on giving of yourself. And even if you don't like the way the partnership is going, divorce is not an option. No wonder many partnerships end in disappointment" Bremner reports. Norris Groves was the stepbrother of George Müller, and a pioneer missionary going counter the mainstreams of the golden age of the modern missions era: he was clearly a VM when it comes to local resources, and even though the biographer makes almost no comments about languages, some parts of Groves diary clearly notes that he was using the local languages and saw it as the thing to do. He faced a lot of opposition, and didn't see much fruit of his work and thoughts, but the ones who were inspired by him and those who came after him had a great impact, and still have in some ways. A great encouragement for everyone who want to be a Vulnerable Missionary that sees himself going mainly against the mainstream of today's missions.

Neil and Carol Anderson are Wycliffe Bible translators in Papua New Guinea. The whole story makes a point that translation is not easy, and how a translator can struggle trying to be as close as possible of the original text and still be understood in the new language and it's context. The preface and the conclusion of the book are really great in advocating the fact that you can't "simply" translate and shows the clear relation in between the language and the context. The story in between is just the illustration of this. (Nothing about local resources in this book. It can be found in french as well, title: "Meilleur que le chocolat" (and maybe other languages?))
